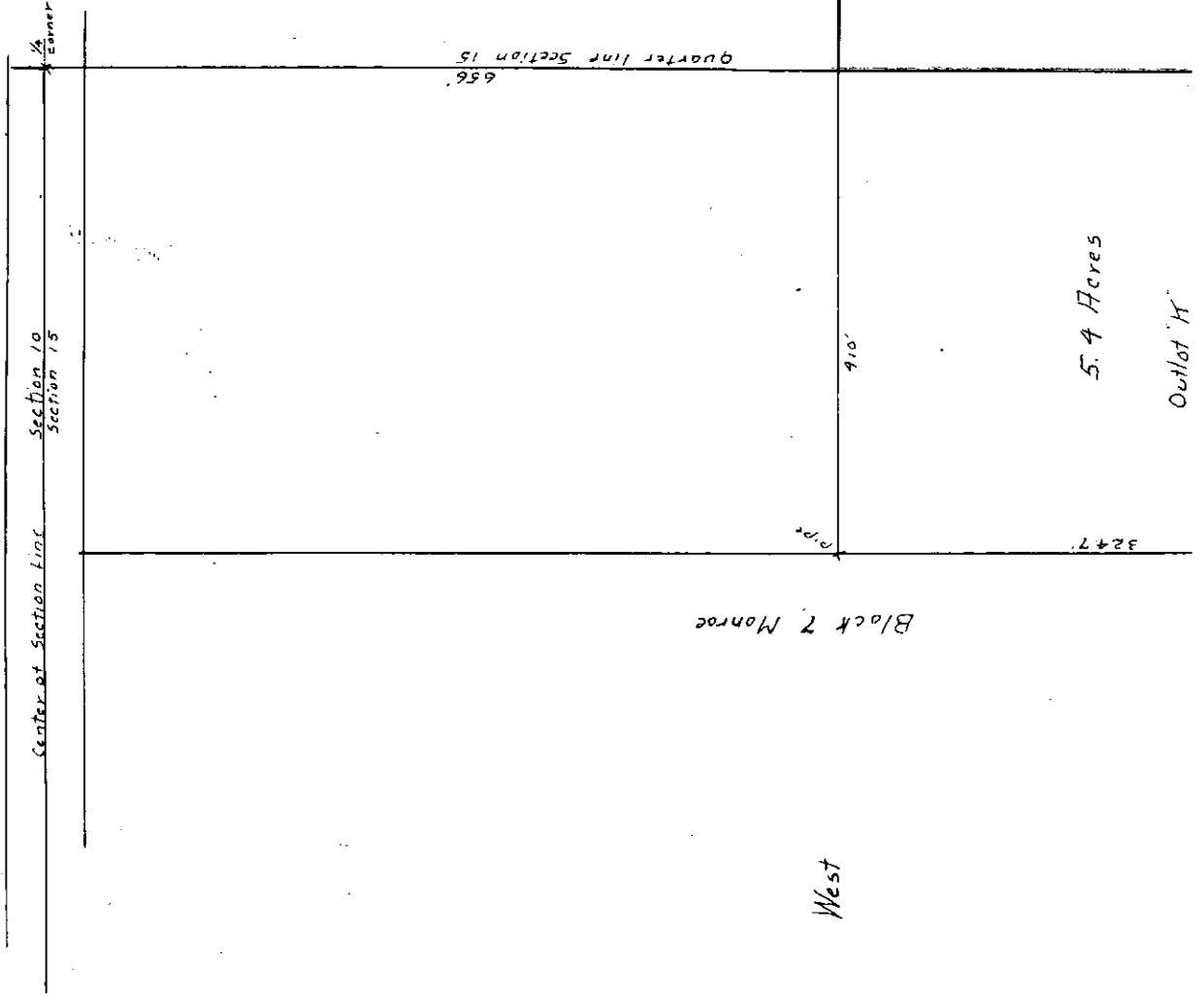
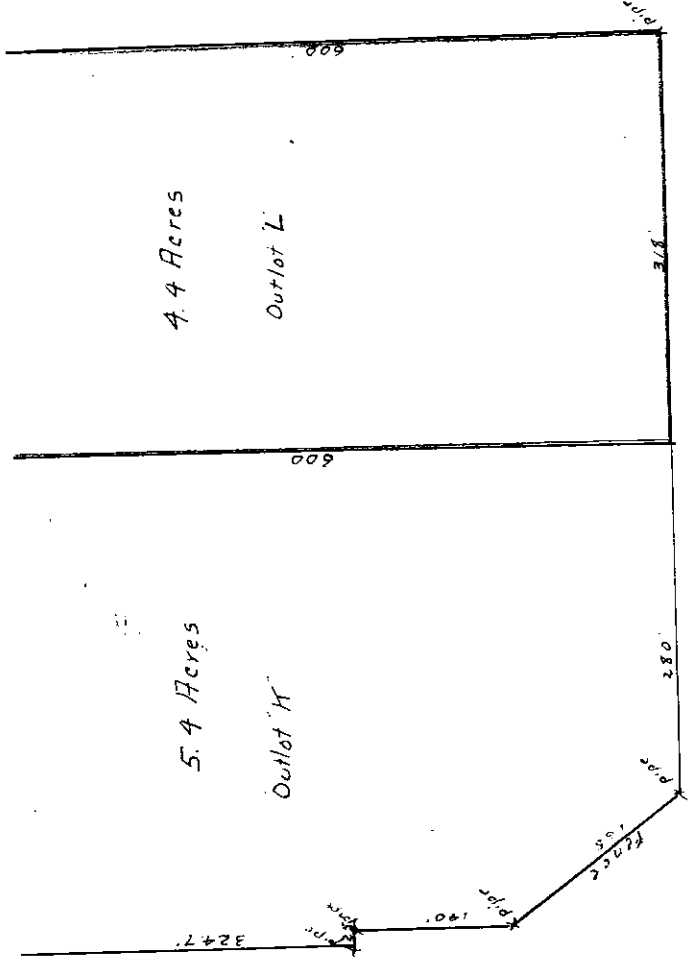

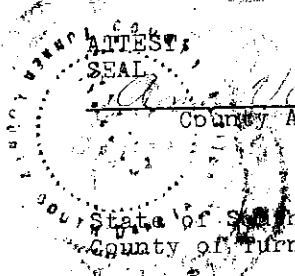
RESOLUTION.

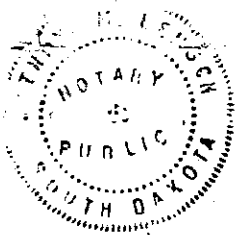

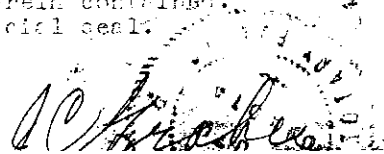

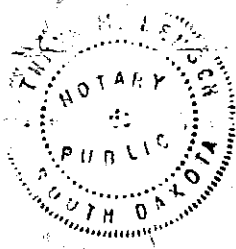
